DIRECTIONS FOR USE

Prior to use, read, understand and follow all label and data page information and all safety information.

Employee education and training in safe handling of this product are recommended.

Testing: Due to the wide variety of substrates, test the product in an inconspicuous area for compatibility prior to full scale application.

New Concrete: Concrete must be fully cured prior to using an auto scrubber on the surface.

Application

Dilute 30 parts water to I part cleaner by volume (I gallon of water to 4 oz of cleaner). The cleaning solution may be run through an auto scrubber or with a mop and bucket. Apply to surface allow to dwell, scrub, remove. **Concrete Clean** should not be allowed to dry on the floor as the dirt will also dry on the surface.

In cases of heavily soiled concrete Concrete Clean should be allowed an extended dwell time before removal. A second application may be necessary.

Limitations

Not recommended for oily surfaces.

Disposal

Dispose of according to current applicable local, state, and federal regulations.
